This product is covered by a limited lifetime replacement product warranty

Vinnova.INC warrants the Product to be free from defects in workmanship and materials under normal use and service for a period of one (1) years from the initial date of purchase by the owner or end-user, contractor, or builder, from Vinnova.INC or an authorized Vinnova.INC dealer.

Subject to the warranty service provision below, any product reported to the authorized dealer or to Vinnova.INC as being defective within the warranty period will be

repaired, replaced (with a product of equal value) or refunded at the discretion of Vinnova.INC. This warranty extends to the original owner or end-user and is not transferable to a subsequent owner.

Neither the distributor, authorized Vinnova.INC dealer, nor any other person has been authorized to make any affirmation, representation, or warranty other than those contained in this warranty. Any affirmation, representation, or warranty other than those contained in this warranty shall not be enforceable against Vinnova.INC or any other people.

Vinnova.INC reserves the right to modify this warranty at any time, it being understood that such modifications will not alter the warranty conditions applicable at the time of sale of the products in question.
