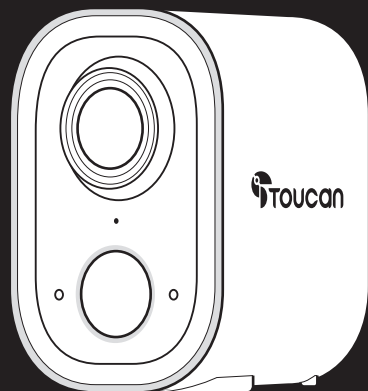




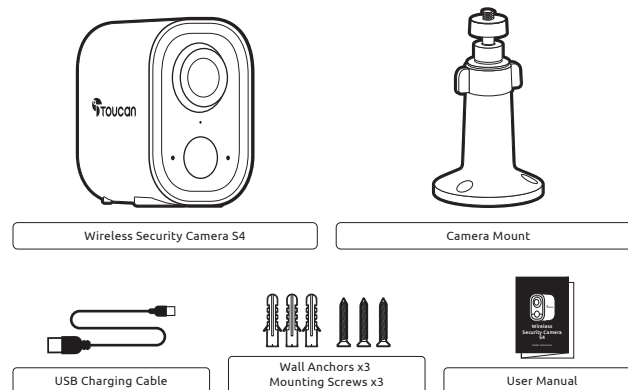

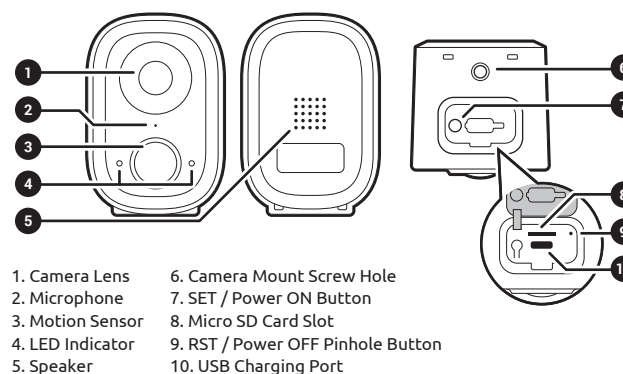

Setup your Wireless Security Camera S4

- Download the Toucan App for Android or iOS



Scan QR code or visit www.toucansolution.com/pages/toucan-smart-home-app
Ensure your Wi-Fi is set to 2.4Ghz before commencing the pairing process (5Ghz not supported)

- Open the app and create a free account
- Tap the dashboard, then tap the "+" button.
- Press and hold the SET button until LED light blinks to enter the setup mode
- Follow the instruction in the Toucan App to complete the setup

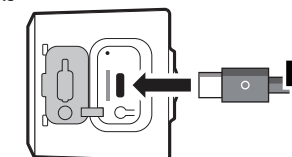
